### ARTICLE I. CALL TO ORDER

#### ARTICLE II. APPROVAL OF MINUTES

a. Budget.

### a. SAFER Grant

Grumney presented information from the Federal Emergency Management Agency Staffing for Adequate Fire and Emergency Response grant. The SAFER grant would pay for three years of staffing then the fire department would have to pick up the following years of employment. The board discussed the grant and local funding. Meshkin said he will look at funding. Grumney will follow the grant which has not yet been approved by Congress.

## b. ISO Fire Department Audit

Den Bleyker said the department is working on the audit, Auditors will be at the station next week.
