Becker asked for an update on No Parking signs on 66<sup>th</sup> Street at entrance/exit to Sanctuary Woods. Meshkin reported that the Allegan County Road Commission requires a traffic study by the Michigan State Police before it will consider a request for the signs.

## ARTICLE VIII. NEW BUSINESS

A. MONARCHS AND MILKWEED. Commissioners discussed a letter from Laura Judge, 6510 Oakwood Lane, Holland, asking the township to plant milkweed at the township hall or Huyser Farm to attract monarch butterflies. All agreed Huyser Farm was the place to plant milkweed at the south end of the parking area.

Motion by Dearborn seconded by Fitch to have the ground prepared at Huyser Farm for milkweed planting. Becker called for a vote on the motion.

UNANIMOUS DECISION – MOTION APPROVED

B. GOAT GRAZING IN PARKS. Fitch has been researching areas that use goats to handle invasive species. The municipalities pay for the goats to eat the ground cover. The goats are kept in a fenced area so they do not harm

- other desirable plants. Commissioners liked the idea. Fitch will get details, including cost, for the next meeting.
- C. DAY OF CARING. United Way Day of Caring is Sept. 17. Volunteers will be at three locations:
  - 1: Laketown Beach. 8 to 11 a.m., 1 to 4 p.m. Clearing branches from signage, repairing snow fencing and cleaning sand from the stairs. Becker will be at the afternoon session.
  - 2: Huyser Farm. 8 to 11 a.m., 1 to 4 p.m. Cleaning weeds and brush from around the berry bushes. Fitch will be present in morning.
  - 3: Gibson Cemetery. No time listed. General clean up. Dearborn will be present.
